The *Preset 10 Portable* can act as a seamless backup for DMX512 lighting consoles or as a stand-alone DMX512 preset console. The *Preset 10 Portable* is capable of storing up to ten presets. These presets are recorded by capturing the output of a DMX512 console. Each preset can be assigned a unique crossfade time, from 0 to 999 seconds. Presets are recalled by pressing one of the buttons.

When operating as a backup device, *Preset 10 Portable* monitors the DMX512 output from your lighting console. If console output is lost, *Preset 10 Portable* begins transmitting to maintain the current look and alerts the user to the loss of DMX. Crossfading to any of the stored presets is then initiated by pressing a preset button

The *PRESET 10* also comes in a wall plate version for architectural applications.
